
CASE IN POINT!

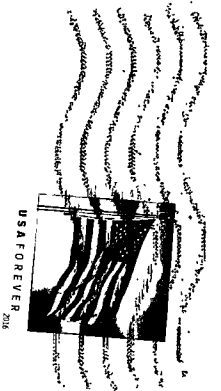
